<b>2. Old Business</b>	<p><b>Old Business</b></p> <ul style="list-style-type: none"> <li>a) Minutes of February’s meeting were reviewed and approved as written. The location is yet to be determined.</li> <li>c) Partners who have transitioned into tobacco free worksites or smoke free housing will be honored during the County’s Tobacco Free Proclamation meeting on May 10, 2016. <b>3. New Business</b>	<p><b>New Business</b></p> <ul style="list-style-type: none"> <li>a) The meeting time, day and location will stay the same for the new fiscal year.</li> <li>b) A SFMUH (Smoke free multiunit housing) case was discussed. One local resident troubled by smoke coming into her apartment from a smoker renting below her, requested assistance and was sent literature about second hand smoke. She attempted to resolve the issue by repeatedly speaking to the offender and the condo association. She retained a lawyer who wrote a letter to the apartment owner and the condo association lawyer. The renter below moved out within 2 weeks of the letters being received. The resident did not have to take the case to court, but she was willing to do so. When confronted from the legal position of non-smokers’ rights to live free of a ‘nuisance’, smokers usually lose in litigation.</li> </ul>
